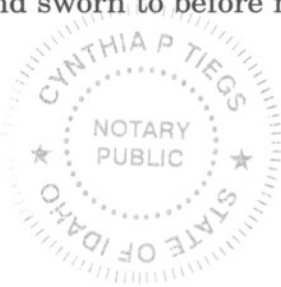


DECLARATION OF CANDIDACY
